**3,182** people with **Alzheimer's and related dementias (ADRD) (in Medicare FFS)** resided in the **32nd US Congressional District** in **California**.


The **Prevalence** of ADRD in the district was **8.09%**, while the **average Prevalence** of ADRD among US Congressional districts in 2018


