2018 Summary

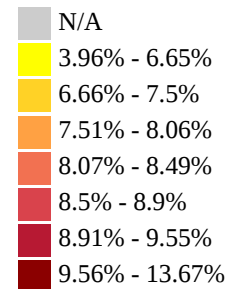
8,255 people with Alzheimer's and related dementias (ADRD) (in Medicare FFS) resided in the 5th US Congressional District in Connecticut.

The **Prevalence** of ADRD in the district was **9.48%**, while the **average Prevalence** of ADRD among US Congressional districts in 2018 was **8.27%**
