2018 Summary

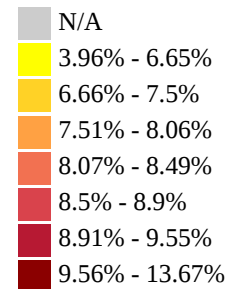
7,176 people with Alzheimer's and related dementias (ADRD) (in Medicare FFS) resided in the 98th US Congressional District in District of Columbia.
