2018 Summary

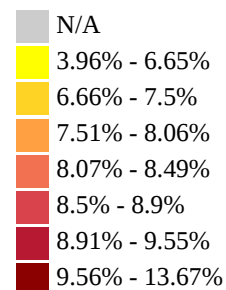
13,966 people with Alzheimer's and related dementias (ADRD) (in Medicare FFS) resided in the 0th US Congressional District in Delaware.
