2018 Summary

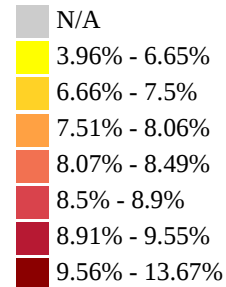
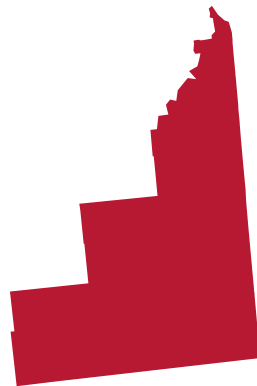
7,596 people with Alzheimer's and related dementias (ADRD) (in Medicare FFS) resided in the 2nd US Congressional District in Illinois.
