2018 Summary

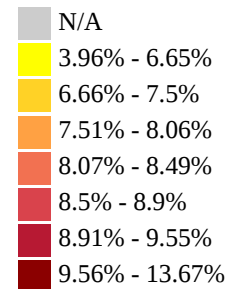
8,144 people with Alzheimer's and related dementias (ADRD) (in Medicare FFS) resided in the 14th US Congressional District in Illinois.
