2018 Summary

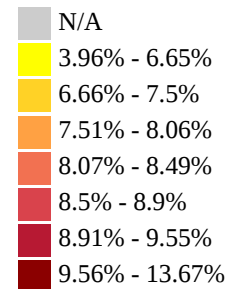
8,048 people with **Alzheimer's and related dementias (ADRD)** (in Medicare FFS) resided in the **16th US Congressional District** in **New York**.
