2018 Summary

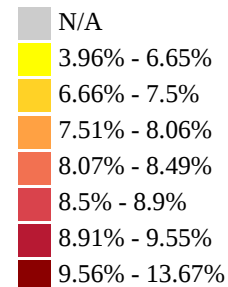
1,888 people with Alzheimer's and related dementias (ADRD) (in Medicare FFS) resided in the 29th US Congressional District in Texas.
