3,437 people with Alzheimer's and related dementias (ADRD) (in Medicare FFS) resided in the 33rd US Congressional District in Texas.


The **Prevalence** of ADRD in the district was **8.61%**, while the **average Prevalence** of ADRD among US Congressional districts in 2018
