2018 Summary

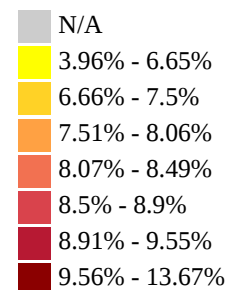
7,118 people with Alzheimer's and related dementias (ADRD) (in Medicare FFS) resided in the 3rd US Congressional District in Virginia.
