2018 Summary

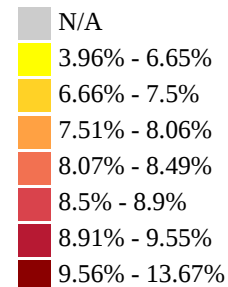
5,519 people with Alzheimer's and related dementias (ADRD) (in Medicare FFS) resided in the 10th US Congressional District in Washington.

The **Prevalence** of ADRD in the district was **6.72%**, while the **average Prevalence** of ADRD among US Congressional districts in 2018 was **8.27%**
